General Instructions to candidate seeking admission to M.Sc. Courses :

- 1. All admissions will be finalized by the Institute.
- 2. If a candidate desires to apply in more than one subject he / she should submit a separate application form for each subject only if they satisfy the eligibility conditions.
- 3. The allotment of seats for admission to post graduate courses in Sciences will be as per circular No. Acad NP/M.Sc./71/2004 of Dr. B.A.M.U. Aurangabad.
- 4. The Candidates are advised to read the prospectus carefully. A candidate applying

for admission to Institute should fill Registration form with requisite information in his/her own hand handwriting correctly. Incomplete application forms/with incorrect information will be rejected.

- 5. Candidate belonging to University other than Dr. Babasaheb Ambedkar Marathwada University is required to obtain a certificate of Eligibility from the Registrar of Dr. Babasaheb Ambedkar Marathwada University before the FIRST TERM ends, failing which he / she will be liable to be declared ineligible for the course. If for some reasons the University declares him / her ineligible for admission, the Institute will cancel such admission and the concerned student will have to leave the course.
- 6. A candidate should bear in mind that he / she can pursue only one course at a time in the University. He / she will have to give a declaration to that effect at the time of applying for admission to a course. Candidates in service will not be considered for admission.
- 7. The applicant has to give his / her permanent home address in the application form which will be registered in the Institute record. Any change there-in will be effected only on an application made by the concerned student duly attested by his / her guardian giving reasons for such a change.
- 8. Re-admission to the same class will not be given.
- 9. Admission for Ph.D. are given as per Dr. Babasaheb Ambedkar Marathawada University directives and availability of seats with concerned guides.
- 10. The rules given here are subject to change as per the directives issued by Dr. Babasaheb Ambedkar Marathawada University and Govt. of Maharashtra from time to time. Any such change(s) will be displayed on the notice board.
- 11. A photocopy of Aadhar card is essential.

Ragging is strictly prohibited in the Institute. Any one found guilty of ragging or abetting ragging is liable to be punished.



- Wrongful restraint;

- Criminal trespass;
- Offences against property;
- Criminal intimidation;
- Attempts to commit any or all of the above mentioned offences against the victim (s);
- Physical or psychological humiliation;
- All other offences following from the definition of "Ragging"

### Punishments for Ragging


As per Regulation No.8 of The UGC Regulation on Curbing the Menace of Ragging in Higher Educational Institution, 2009, depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the Institution, the possible punishments for those found guilty or ragging at the Institutional level shall be any one or any combination of the following.

- Suspension from attending classes and academic privileges.
- Withholding/withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension / expulsion from the hostel.
- Cancellation of admission.
- Rustication from the institution for period ragging from 1 to 4 semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
- Fine ragging between Rupees 25,000/- and Rupees 1 lakh.
- Collective punishment : When the person committing or abetting the crime of ragging are not identified, the institution

#### Registration

- 1. Registration form together with the prospectus can be obtained from the Institute Office on payment of 50/- in person at the counter or through D.D. drawn in favour of the **Director, Institute of Science, Aurangabad.**
- 2. The candidate should fill Registration Form in his/her own handwriting and completely filled-in Registration Form along with registration fees of 25/- in cash of D.D. in the name of **Director, Institute of Science, Aurangabad.,** should reach the office on or before last date as prescribed by Institute.
- 3. Institute will not be responsible for any postal of any kind of delay. Incomplete Registration Forms will be rejected.
- 4. The Registration Form must be accompanied by the following documents duly attested by Gazetted Officer / Principal /Teaching faculty of any college/university and complete in all respect.

(a) True copies of all the Marks Memos( passed, failed, A.T.K.T. and failed) of B.Sc., I, II and III year examinations or other qualifying examination as mentioned in eligibility criteria.

(b) True copies of Marks memo and certificates of S.S.C. & H.S.C. Examinations.

(c) True copy of the Migration Certificate (For those who have passed the qualifying Examination from University other than Dr. Babasaheb Ambedkar Marathwada University).

(d) True copy of the College Leaving Certificate / T. C.

- (T. C. submitted, should have all its columns filled in by the issuing authority.)
- (e) Recent pass-port size photograph of the candidate be affixed to the Registration form.

(f) True copy of the Caste Certificate, relevant document from competent authority(if admission is sought under reserved category) and original caste verification certificate from State Social Welfare Department should be submitted at the time of admission. NT 2, NT3 and OBC Candidates should submit Recent true copy of Creamy layer certificate.

(g) Nationality & Domicile certificate (for candidates other than Maharashtra State)

ALL ORIGINAL CERTIFICATES NEED TO BE SUBMITTED AT THE TIME OF ADMISSION WITHOUT FAIL ALONG WITH THE PRESCRIBED FEES.

#### Scrutiny and display of Tentative & Final General Merit List :

The registration forms will be scrutinized based on eligibility criteria and prescribed rules

- 1. Candidates with less than 45% in all the optional subjects taken together at their qualifying examinations will not be admitted to M.Sc. Course. However, the candidates belonging to reserved categories should have a minimum of 40% marks.
- 2. Admission made to any course of study in the Institute will be provisional, subject to confirmation of eligibility by the Dr. Babasaheb Ambedkar Marathwada University. The Institute will not be responsible, if the Candidate is not found eligible by the University.
- 3. In case of candidates passing the qualifying examination in more than the stipulated attempts, 2% marks will be deducted for each additional attempt, while preparing the merit list.
- 4. The details of seats under reserved category are given below :

- 5. 3% seats are reserved for physically handicapped candidates. However these seats will be filled from the respective category.
- 6. Admission once given in a specific subject will not be changed unless approved by the Director of the Institute.
- 7. The Director reserves the right to refuse admission to a candidate in the interest of discipline and academic standard of the Institute.
- 8. Foreign students seeking admission to this Institute must ensure that all their papers are clear and as per the Govt. of India rules and regulations.

2. Students belonging to reserved category need to pay B+C Fees, Students claiming EBC need to pay full fees (on sanction A component is refundable).

- 3. Foreign students on admission will have to pay the amount of fees as prescribed by university
- 4. Caution Money and Library Deposit are refundable when the student leaves the Institute on getting NOC from the concerned Department. A student should apply for refund of the same within one complete year, after he/she actually leaves the Institute either by obtaining the leaving certificate or by informing in writing of his/her intention to leave the Institute OR within one complete financial year after the date of successful completion of the course, whichever is earlier.
- 5. (a) Caution money and Library deposit if not claimed by the student within the prescribed time limit will be forfeited.

(b) A student discontinuing studies for the M.Sc course is required to give satisfactory reasons for doing so, otherwise the tuition fees and Library deposit are liable to be forfeited.

(c) The whole amount of tuition fees will be refunded to the student, if his/her provisional admission is cancelled by the University.

(I) 90% of the consolidated fees actually paid may be refunded to the student who cancels admission and make a written application for the refund of fees to the Director, Institute of Science within 15 days from the date of his / her admission.

(ii) 50% of the consolidated fees actually paid by the student may be refunded if he/she applies for refund of fees after on or before 31st august of the same year. Original receipts should be enclosed with the application for refund of fees.

(iii) After 31st August the claim for refund of fees will not be entertained under any circumstances.

### **General Instructions and Discipline :**

Every Student shall adhere strictly to the undertaking given in application form and to the conduct of rules.

- (I) Students should produce their Identity Card on demand when they are in the premises of the Institute.
- (ii) Students are expected to maintain discipline and behave in polite manner while they are in the Institute premises. They should not act in any way which would undermine the expected high traditions of the Institute.
- (iii) Students must not remain absent from the Institute classes or examinations without the prior permission from the concerned Head of the Department.
- (iv) Students must attend more than 75% of theory & practical classes and they must show satisfactory performance in the first and second terminal examinations,failing which the student will not be allowed to appear for the University Final Examination. (GR.NO. TEH 3396(3428 Vm. शि. मंत्रालय विस्तार भवन, मुंबई 400 032, 17-4-96) E.B.C. and G.O.I. & other Scholarship holders must

have 75% attendance and satisfactory performance in all the examinations of the Institute (vide G.R.No. E.B.C.-1037/39442/949/MBK-2 dated 7-9-1988), failing which the necessary actions will be taken as per the prescribed rules.

- (v) Extra Curricular activities and functions of the students forum will be performed in the Institute in consultation with and after obtaining prior permission from the Director, Institute has established Alumni Association. All the students completing the M.Sc. courses from Institute are encouraged to become members.
- (vi) Guests shall be invited to deliver lectures in the Institute after seeking the permission from Director.
- (vii) Students must do nothing either inside or outside the Institute that will interfere with the orderly governance and discipline of the Institute.
- (viii) Students are strictly prohibited from smoking and chewing tobacco in the Institute premises. They are advised not to spoil the walls and corridors. They are expected to help to maintain Institute premises neat and clean.
- (ix) Students should be vigilant and take care to see that the books, equipments and any Institute material they use are not damaged and see that the Institute does not suffer any loss because of their negligence.
- (x) The students will return all the apparatus issued to him / her to the Laboratory Assistant / Stores keeper. He / She shall return the Library books issued to him/her in time.
- (xi) The decision of the Director shall be final in matter pertaining to discipline and penalties imposed on those violating the rules and undermining discipline of the Institute.
- (xii) To qualify for appearing the University examination a student
- 1) Must attend not less than 75% of the lectures and practicals.
- 2) Must satisfy the Institute authorities with regard to his / her proficiency and academic fitness in the subject by showing good performance in the Institute examinations and seminars conducted during the academic year.
- 3) No student should remain absent from the Institute without the prior permission of the Director. In case of absence due to illness, a medical certificate from the Registered Medical Practitioners should be submitted and such absence should be reported to the Director immediately. Medical Certificates should be submitted within 10 days from the first day of the absence on account of illness. In such cases a 10% relaxation in the attendance will be considered. The Director reserves the right of allowing / disallowing any student from appearing for the University examination on recommendation of the committee. However, the decision of the Director will be final.
- (xiii) All legal matters are Subject to Aurangabad Jurisdiction.
- (xiv) Any item not covered by the above rules lies under the discretionary powers of the Director.

## ADMISSION TO M.Sc. BIOTECHNOLOGY AND MICROBIOLOGY COURSE

## ENTRANCE EXAMINATION - BTEE - 2015 GENERAL RULES & REGULATIONS

- Admission to the course will be given from amongst the successful candidates (General and Reservation categories) as per merit in Entrance Examination.
- B) State Government Rules on reservation will be observed strictly while admitting candidates from the reservation categories for the Course.
- C) Students desirous to appear for Entrance Examination should apply in prescribed form enclosed on or before Last date along with the demand draft of prescribed amount in the favor of Director, Govt. Institute of Science, Aurangabad. The reserved category candidate should submit a photo copy of caste certificate at the time of procuring the Entrance Examination form.
- D) Application from duly completed along with the attested copies of documents as per (F) below, Entrance Examination Free and two copies of recent passport size photographs should reach this office.
- E) Important Note: Enclose attested copies of -i) All marks memo of Graduation, S.S.C., H.S.C.

ii) Certificate Claiming reservation.

- F) Candidates should submit the application within the due date and collect Entrance Examination Admit Card from office immediately. Students should produce the Admit card at the time of entrance examination.
- G) Candidates belonging to OBC, NT-2 and NT-3 should produce latest copy of non-creamy layer certificate. All reserved category candidates should produce caste validity certificate at the time of admission.
- H) The result and the names of the short listed candidates (General merit list & Provisional admission list) will be displayed on the office Notice Board Candidate from first admission list should bring all the required original documents / certificate along with two sets of attested xerox copies of each and the required fees while coming of admission.

## ADMISSION TO M.Sc. BIOTECHNOLOGY COURSE ENTRANCE EXAMINATION - BTEE - 2015 RULES & REGULATIONS

#### 1) Eligibility :

i) As per Ordinance 498 (VII) of Dr. Babasaheb Ambedkar Marathwada University, Aurangabad, the candidate must be a Science Graduate OR B. Pharm OR B.Sc. (Agri) OR B.Sc. integrated in Biotechnology / Bioinformatics.

ii) Candidate desirous to appear for entrance examination must secure minimum 45% marks (40% for reservation categories) at their qualifying degree examination.
iii) The allotment of Seats will be as per Circular No. Acad/NP/M.Sc/71/2004 29693-782 dated 15/03/2004 of Dr. Babasaheb Ambedkar Marathwada University, Aurangabad.
