

MEMORANDUM OF UNDERSTANDING

Poona College of Pharmacy, Bharati Vidyapeeth (Deemed to be) University, Erandwane, Pune, here in after referred as the FIRST PARTY (which term unless the context otherwise requires shall include its representatives, successors of assignees of second party)

&

Government Institute of Science, Nipat Niranjan Nagar, Aurangabad, referred as the SECOND PARTY (which term unless the context otherwise requires shall include its representatives, successors of assignees of first party)

PREAMBLE

In the current academic scenario, it is the need of the hour to work in collaborations to achieve and maintain the Educational and Research Standards in any institution. A free exchange of knowledge and ideas help in enhancing skills, creativity and innovativeness for all-round development of students. This also helps in tackling the local problems for sustainable development of the area and development of the Nation as a whole.

a) Poona College of Pharmacy, Bharati Vidyapeeth (Deemed to be) University, Erandwane, Pune is a renowned Pharmacy Institute of Pune area, established in 1981. It is approved by AICTE, PCI and UGC. It is now a constituent unit of Bharati Vidyapeeth (Deemed to be University). It is a grant-in-aid institute, conducting Graduate, Post-graduate and Doctoral programmes in Pharmaceutical Sciences. The institute is accredited by NBA, NAAC. The Institute has well-equipped laboratories with ultra modern facilities supported by highly qualified teaching faculty in all branches created by the





Institute. The Institute has well furnished Central Library facility with reference books, textbooks, National and International Journals and internet facility to boost learning efforts.

b) Government Institute of Science, Nipat Niranjan nagar, Aurangabad (Maharashtra). The Government Institute of Science, Aurangabad was established in 1974, in the purview of development of Marathwada region. It is a post graduate teaching and research institute funded by and administered by the Government of Maharashtra and Babasaheb Ambedkar Marathwada University, Aurangabad affiliated to Dr. (Maharashtra). Situated in 25 acres of picturesque campus at the foothills of Aurangabad Caves, the Institute houses five unique PG departments, viz. Biophysics, Biotechnology, Botany, Geology and Microbiology. 


- 1. Usage of Animal House/Instrumental facilities by the students and faculty with prior permission of Head of the institutes of both the parties.
- 2. Usage of library books, study material, e-journals, etc, under the Inter-Library Loan (ILL) facility, by the students and faculty with prior permission of Head of the institutes of both the parties.

Now this deed of MOU is agreed by and between the parties under following terms and condition:

TERMS AND CONDITIONS:

- 1. The library facilities will be shared at the premises of **BOTH THE PARTIES** as per the need of work mutually agreed upon.
- 2. The Animal House/instrumental facilities will be shared at the premises of **BOTH THE**PARTIES as per the need of work mutually agreed upon.
- 3. **BOTH THE PARTIES** may work together on multiple scientific projects, submission of joint R&D proposals for funding, manpower training and exchange, student training programmes, dissertation work, laboratory analyses, educational visits, etc.
- 4. BOTH THE PARTIES will extend their cooperation and collaboration for research activities, patents and publications.
- 5. BOTH THE PARTIES may allow students to utilize the expertise of faculty and/or students of their organizations. The required books and/or study material will be issued to the students in college premises (if applicable) for their studies other than those available with SECOND PARTY and are to be made available by FIRST PARTY and Vice Versa.
- 6. **BOTH THE PARTIES** agree to enter into detailed agreements on a case-to-case basis, with a defined objective specifying the scope of the work and mutual obligations, terms and conditions, financial arrangements, IPR and other contractual obligations.
- 7. Any publication(s) related to the work/study shall acknowledge the assistance provided (if any) by the FIRST PARTY and vice-versa.
- 8. All facilities shared between BOTH THE PARTIES shall be reviewed every year by joint committee appointed for the purpose by BOTH THE PARTIES in order to advice on the future course of sharing.
- 9. Any dispute arising shall be settled through mutual negotiations only without recourse to resolving the dispute by legal means or at the most by arbitration on mutual terms.

This MoU is not intended to constitute, create, give effect to, or otherwise recognize a joint venture, agency, partnership or formal business organization of any kind. Each party hereto shall act as an independent entity and neither shall act as an agent of either party for other purposes. Neither party has the authority to bind the other party.

Non-exclusivity:

The agreement reflected by the provisions of thius MoU is non-exclusive in nature and both parties can enter into cooperative arrangements with other parties to suit their organizational needs.

Confidentiality:


The parties understand that in the course of their association, they shall have access to confidential information provided by the other party. Accordingly, the parties agree that such information which is by its nature, not confidential or which is in the public domain or which the party comes to know about other than through violation of any law of legal obligation, provided that such party may be entitled to disclose such information if legally required to be disclosed to the competent authority. Failure to maintain confidentiality shall entitle the affected party to terminate the MoU.

Validity:

This MoU will be valid for a period of five years from the date of signing and can be further renewed by both the parties as per mutually agreed terms and conditions. If the MoU is not extended after five years, then the ongoing activities will be completed and no further new activities will be initiated, till extension. Either party can terminate the MoU after giving a one month's notice to the other party subject to fulfilment of commitments already agreed upon.

Ammendments:

This MoU constitutes the entire understanding between the parties hereto. Except as otherwise provided herein, no addition, ammendment to or modification of this MoU shall be effected unless it in writing and signed by and on behalf of both parties by their respective authorised signatories.


